IN THIS PROGRAM, RUN IN 2010 AND 2011, 2012 WE BROUGHT OFFICERS FROM THE DEPARTMENT OF COMMAND AND LEADERSHIP AT THE U.S. ARMY COMMAND AND GENERAL STAFF COLLEGE AT FORT LEAVENWORTH, KANSAS, TO THE HOLOCAUST SITE OF AUSCHWITZ IN POLAND FOR ONE WEEK OF EDUCATION IN PREVENTING MASS ATROCITIES AND PROTECTING CIVILIANS DURING MILITARY OPERATIONS.
