## AIPR Raphael Lemkin Seminar for Genocide Prevention Latin American Network Edition, June 2013

## Goals of the Seminar:

(1) To familiarize participants with the concept of genocide, its relation to the broader category of mass atrocity, and the processes by which genocide occurs.

(2) To empower participants with the practical competencies (knowledge and skills) necessary to develop the means to identify and deter the potential for genocide, limit genocide as it unfolds, and engage in the best practices of post-conflict peacebuilding that aim to prevent the future occurrence of mass atrocity in a post-conflict society.

(3) To critically examine the emerging international security and human rights norm of the responsibility to protect, with clear recognition of the idea that sovereignty is not a privilege, but a responsibility.

(4) To foster intercultural dialogue in an open and respectful exchange between individuals with different cultural backgrounds or worldviews with the aim of developing a deeper understanding of diverse perspectives and practices, with a particular focus on the role played by discrimination and "otherness" in fostering inequality.

(5) To strengthen the Latin American Network for Genocide and Mass Atrocity Prevention by creating a communication network of genocide-sensitive policymakers, shapers of political will, who will become agents of genocide and mass atrocity prevention with a heightened degree of awareness and sensitivity to the role of non-governmental actors in supporting their work in zones of conflict.

## Overview of the Seminar

This seminar is grounded in the belief that preventing genocide and mass atrocity is an achievable goal. That is, there are ways to recognize its signs and symptoms, and viable options to prevent it at every turn if we are committed and prepared. Buttressed by an international teaching team of scholars and activists, the seminar follows the "situated learning" model of education by being grounded in the "power of place" at Auschwitz, the most notorious of the Nazi extermination camps. This seminar is meant to educate officials (just beginning or having recently begun their appointment) of the human rights organisms of Ministries of Foreign Affairs, Ministries of Justice, Ministries of Defense, National Mechanisms for Mass Atrocity and Genocide Prevention and all civil servants of the National and Inter-ministerial commissions for Human Rights and International Humanitarian Law, on mass atrocity and genocide prevention policy, thus developing these organisms' capacity to effectively prevent the horrors caused by these crimes. Reading materials, case studies and other active learning assignments will allow participants to engage firsthand with the learning resources and presentation material. The seminar will follow the Chatham House Rule in which participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed.
